(Issued under provision No. 05 & 13 of University Direction No. 02/2016)

Sir / Madam,

With reference to above cited subject, I am directed to communicate that, as per the University laid down procedure & your proposal for Continuation of Affiliation & / or Extension of Affiliation, the Academic Council is pleased to grant **conditional Continuation of Affiliation & / or Extension of Affiliation** (in view of the above referred resolution of the Academic Council) **for Academic Year 2026-27** under Sections 65(4), 68 and 69 of the Maharashtra University of Health Sciences Act, 1998, for the **Under Graduate M.B.B.S. Course** of your College with Intake Capacity of **100 seats** subject to the permission granted by Central Government / National Medical Commission/ / State Government (as applicable).

Important Instruction regarding Teaching Staff:

(i) A) Required Teaching Staff should be maintained as per MSR of National Medical Commission (NMC).

B) As per the MUHS Academic Council Resolution No.481/2026, College should have minimum 70% & above Teaching Staff and Approved Teaching Staff should be 60% & above.

(ii) Deficiencies in Hospital for compliance : Nil

(iii) Deficiencies in College for compliance : Nil

(iv) Deficiencies in Hostel for compliance : Nil

(v) Other Deficiencies , if any : Nil

(vi) Other:

- a. The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (format attached).
- b. For those UG / PG qualifications that are not yet recognized by the Central Govt., it shall be mandatory for the College to apply to the Central Council / Commission through Central Govt. and ensure that "Permitted" / "Not Recognized" qualifications are enlisted in "Recognized Qualifications", failing which University shall not grant Continuation of Affiliation to such courses from ensuing Academic Year and no student shall be admitted in such courses.

(vii) Settlement of University Dues:

If any advances, dues or affiliation fees payable to any section of the University are pending, the same shall be cleared within three (03) months. Failing such compliance, no action shall be taken on proposals received from your college regarding approval of teachers or grant of PG Recognition or other.

(viii) Other Conditions:

- a. This **conditional** Continuation / Extension of affiliation is issued for the A.Y. 2026-2027 subject to the permission of National Medical Commission and / or Government of India. Further, if the permission is declined by the said authorities, this conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1st Year of the course until receipt of permission of the National Medical Commission and / or Government of India.
- b. Admissions shall be made only through the Competent Authority.
- c. If the **National Medical Commission (NMC)** has granted conditional renewal/permission to the College for the Academic Year 2026-27, subject to compliance with the discrepancies/deficiencies within the stipulated time period as specified in the NMC communication, and if subsequently the NMC takes any action for revocation of such conditional renewal/permission, reduction in the sanctioned intake capacity, or any other adverse action, the decision of the National Medical Commission in this regard shall be final and binding. Accordingly, the conditional Continuation/Extension of Affiliation granted by the University shall remain subject to the decision of the National Medical Commission and compliance with the deficiencies communicated by the University.

(IX) IMPORTANT NOTES FOR STRICT ADHERANCE:

- a. The College shall comply with all the provisions of the Maharashtra University of Health Sciences Act, 1998, the Statutes, Ordinances, Regulations, Directions, and all applicable norms, regulations and guidelines issued by the concerned Central Council/Commission, the State Government and the University from time to time.

- b. Grant of Continuation/Extension of Affiliation for the Academic Year 2026-27 shall not confer any vested right upon the College to claim Continuation/Extension of Affiliation for subsequent academic years. Each proposal shall be considered independently in accordance with the prevailing statutory provisions and regulatory norms.
- c. The University reserves the right to conduct inspection(s) of the College and its attached teaching hospital at any time during the academic year to verify compliance with statutory provisions and regulatory norms.
- d. Failure to rectify the deficiencies within the stipulated period shall render the College liable for appropriate action under the provisions of the MUHS Act, 1998, including withdrawal or refusal of Continuation/Extension of Affiliation, reduction of intake capacity or any other action deemed appropriate by the University.
- e. If any information, declaration or document submitted by the College is found to be false, incorrect, misleading or suppressed at any stage, the Continuation/Extension of Affiliation granted under this order shall be liable to be withdrawn without prejudice to any other action permissible under law.
- f. No student or institution shall claim any equity or special consideration on the basis of admissions made in violation of the provisions of this order or any applicable statutory provisions.
